BUTLER COUNTY BOARD OF SUPERVISORS

November 14, 2022

An emergency meeting of the Board of Supervisors of Butler County, Nebraska was held on the 14th day of November 2022 at the Butler County Courthouse in David City, Nebraska at 5:00 p.m. Pursuant to §84-1411(5); the purpose of the Emergency Meeting: Discussion/Possible Action - Re-hire 3 former employees as dispatchers (Scott Steager, Jill Behle, and Jerry Oborny).

Present were the following: Anthony Whitmore, Tony Krafka, Scot Bauer, David W. Mach, Jan Sypal, and Robert Coufal. Absent: Ryan Svoboda.

Pursuant to §84-1411(4), notice of the meeting was sent via email as a press release to the Banner Press prior to calling the meeting to order. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

The Pledge of Allegiance was recited by all present.

The Chairman called the meeting to order and announced that a complete copy of the Open Meetings Act is posted in the meeting room.

Discussion/Possible Action - Re-hire 3 former employees as dispatchers (Scott Steager, Jill Behle, and Jerry Oborny)

Chairman Whitmore addressed those in attendance the need for the emergency meeting was due to lack of staff in the 911 Center and the need to run a 24/7 facility. Three former employees are being considered for re-hire as temporary part-time help.

Moved by Mach, seconded by Sypal to rehire Jerry Oborny as a temporary part-time dispatcher. Upon roll call vote the following voted aye: Mach, Sypal, Coufal, Krafka, Bauer, and Whitmore. The following voted nay: NONE. Absent: Svoboda. Motion carried.

Moved by Coufal, seconded by Bauer to rehire Scott Steager as a temporary part-time dispatcher. Upon roll call vote the following voted aye: Coufal, Krafka, Bauer, Mach, Sypal, and Whitmore. The following voted nay: NONE. Absent: Svoboda. Motion carried.

Moved by Krafka, seconded by Sypal to move into executive session to discuss concerns about an applicant, inviting Human Resource Director, Heidi Loges, and County Attorney Julie Reiter at 5:05 p.m. Upon roll call vote the following voted aye: Krafka, Coufal, Sypal, Mach, Bauer, and Whitmore. The following voted nay: NONE. Absent: Svoboda. Motion carried.

Moved by Sypal, seconded by Mach to exit executive session at 5:18 p.m. Upon roll call vote the following voted aye: Sypal, Mach, Bauer, Krafka, Coufal, and Whitmore. The following voted nay: NONE. Absent: Svoboda. Motion carried.

Moved by Coufal, seconded by Bauer to re-hire Jill Behle as a temporary part-time dispatcher. Upon roll call vote the following voted aye: Coufal, Krafka, Bauer, Sypal, and Whitmore. The following voted nay: Mach. Absent: Svoboda. Motion carried.

There being no further business to come before the board, the Chairman adjourned the meeting at 5:21 p.m. The next scheduled meeting of the Board of Supervisors will be November 21, 2022, at 9:00 a.m.
