Discussion/possible action regarding budget increase for FY 2025-2026

The Consumer Price Index (CPI) for this region is 2.80% and the Nebraska Auditor of Public Accounts' Growth and Inflation Percentage for 2025-2026 is 5.17%. Discussion was held regarding what percentage increase to recommend to departments. Moved by Krafka to recommend a budget increase of 2.80% for FY 2025-2026. Motion died for lack of a second. Discussion tabled until later in the meeting.

Jerome Andel – ROW Trees and Mowing

Jerome Andel came before the Board to express concern about trees and mowing in the right-of-way (ROW). Mowing and tree removal from the ROW is the responsibility of the property/landowners, but not all property owners meet this obligation. Some of the townships have sent letters reminding property/landowners of this responsibility, and some property owners take care of it, but others do not. Andel asked about enforcement. Highway Superintendent Randy Isham stated that the County does not have time to monitor and maintain all of the ROWs. Townships need to be more involved in enforcement and take care of ROWs if property owners do not. Isham will talk to the townships and encouraged board members to talk to the townships in their respective districts as well.
