January 5, 2026

A meeting of the Board of Supervisors of Butler County, Nebraska, was held on the 5th day of January 2026 at the Butler County Courthouse in David City, Nebraska at 9:00 a.m.

A bid for \$18,799.78 includes seven individual microphones to be placed in between board members. Each microphone has an on/off switch to allow for sidebar conversations if needed, should the Board decide to start recording meetings. A bid for \$13,259.44 includes one larger microphone to be installed in the ceiling. Both would work with the TV and speaker(s) already in the room. Discussion was held. Moved by Vandenberg, seconded by Coufal to approve the bid for \$18,799.78, to be taken from General/Miscellaneous. Further discussion was held; Supervisor Griess suggested the Board wait until they see how the new system at the highway building works first. Motion withdrawn by Vandenberg. County Clerk Aschoff noted that the equipment included in the two bids being considered is not the same equipment being installed at the highway building. Crews are busy maintaining roads and stockpiling gravel; both excavators are repaired and in service. Regarding the bridge west of Linwood, Isham said he will have to hire a longstick backhoe to cut out the channel. Bridge Inspector Jim Novacek is done with bridge inspections for the year.
